NOTICE OF SPECIAL ELECTION

PERSONAL REGISTRATION

NOTICE IS HEREBY GIVEN, that a special election of the qualified electors of the Town of Irondequoit, Monroe County, New York, shall be held on the 30th day of July, 2019, in said Town for the purpose of voting upon a proposition with respect to a bond resolution authorizing up to \$7,250,000 bonds of the Town of Irondequoit, Monroe County, New York to finance the construction, reconstruction and equipping of portions of certain buildings leased by the Town and located at the Skyview on the Ridge with former address of 285 Medley Centre Parkway, encompassing tax parcels 092-050-1-085.111, 092-050-1-085.200, 092-050-1-087.100 and 092-050-1-086.000 (formerly known as the Medley Centre) for use as a new community center including but not limited to, a gymnasium, a fitness center, community meeting rooms, facilities to house the Town's senior programs, and office space for the Town's Bureau of Recreation, the construction of modifications to the exterior entrance, including a drop off area at the designated entrance to the community center, and the equipping thereof, and related site work improvements, and all ancillary and related improvements, costs and expenses, which does not take effect until a proposition for the approval thereof has been approved at a special election by the qualified electors of said Town. Details concerning the proposition are on file in the office of the Town Clerk, located at 1280 Titus Avenue in the Town of Irondequoit and may be examined by any interested person during regular business hours.

NOTICE IS HEREBY FURTHER GIVEN, that personal registration is required and electors shall only be entitled to vote at said special election if his or her name appears on the register of said Town prepared for such special election, or such elector registers as hereinafter provided. The Town Board of Registration shall prepare a register for said special election, which register shall include all electors registered under the provisions of Article 5 of the Election Law. Any registered elector whose name appears on such register need not register again for such special election.

NOTICE IS HEREBY FURTHER GIVEN, that personal registration shall be held from 12:00 P.M. until 4:00 P.M. on July 15th, 2019, at the Christ the King School Gymnasium, 445 Kings Highway South, at which time any person shall be entitled to have his/her name placed upon such registers, provided that at such meeting of the Board of Registration, he/she is known or proved to the satisfaction of such Board of Registration to be then or thereafter entitled to vote at said Special Election. At such hours and place, any person who is not currently registered under permanent personal registration on the lists of registered voters furnished by the Monroe County Board of Elections as of the date of this publication must present himself or herself personally for registration, in order to be entitled to vote at said Special Election to be held on July 30th, 2019.
